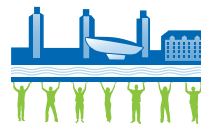

Support Local Businesses

Economic studies show that more of the money you spend stays in your community when spent at locally owned businesses.

For every \$100 spent

at chain stores



\$43 stays in the community

at locally owned businesses



\$73 stays in the community

Locally owned businesses offer many other advantages:

1. Studies show that a strong local business sector is associated with higher nonprofit activity, social capital, and voter turnout.
2. Local businesses often provide better service and unique products, including products from other small businesses around the world.
3. Local businesses do not pull up and leave the community in search of higher profits elsewhere; they are pillars of the community.
4. Locally owned, independent businesses are not driven solely by profits. They are better able to balance their business needs with investments in people, the planet, and the community.
5. Local businesses pay taxes and generate new jobs without seeking unnecessary tax breaks and subsidies from local governments.
